Academy Grants: Eighteen at-risk boys were provided boarding, clothing, education, soccer training, match participation, discipleship, and given life and vocational skills to be successful upon graduation from the academy. Programs include community service out-reach performed by athletes to improve their community.

Emergency Aid: Provided over 60,000 emergency meals to families involved in academy, catch-up school, co-op, and community training programs during economic downturn from pandemic and provided mentoring and emergency conflict resolution to keep families together and safe.
